
1. Call meeting to order:
2. Roll call and verify quorum:
3. Public Comment: Members of the public may address the Board for a maximum of three minutes on items not on the current agenda. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda;
4. Public comment on agenda items. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item;
5. Receive monthly report from Treasurer and consider:
 - (a) approval of payment of monthly invoices and payroll; and
 - (b) approval of monthly Statement of Financial Position, Income Statement of Budget performance and Reconciliation Summaries of ESD #4's Ozona Bank Accounts;
6. Receive monthly report from Fire Chief regarding emergency operations, response times, call volume, training, management activities, career and volunteer personnel;
7. Receive Fire Chief report on apparatus, equipment, repairs, and item purchases;
8. Receive monthly report from District's Attorney regarding pending litigation matters, contract issues, and legislative efforts and consider taking related action;

9. Discuss and consider additional Administrative Office staff, take any related action; *potential candidate. Deena and I met with her. Seems to meet the unique nature of the dept. Intelligent, good natured. Meet with chiefs and ron and any other board members end of this week.*

11. Discuss and consider Draft HCESD4 Fire Inspection Policy, take any related action; *Interlocal agreement revision has been received from Carlton Law. Board to consider training firefighters and captains vs hiring fire inspectors part time vs contracting with independent contractor. Employee benefits and administrative support not applicable.*

Discuss and consider Central Station addition, change orders, construction update, material delays and increase amount of the GC contract to reflect approved change orders, and increase amount of the Architect contract to reflect work performed beyond contract; take any related action; *demand for payment \$770 to be withheld from next GC payment and pay them directly. Chief discussed with gc to see if they will pay. We'll confirm with vendor prior to next payment.*
