Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 7. Discuss and consider action on monthly report from District's Attorney regarding pending litigation matters, contract issues, tax and budgeting issues, and legislative efforts;
- 8. Discuss and consider Revised District Investment Policy, approving the Resolution Adopting Revised Investment Policy, Strategies, Guidelines and Management Practices, and authorizing the Board President to Execute the Resolution;
- 9. Discuss and consider action regarding the District's property in Burnet Ranches;
- 10. Discuss and consider action regarding Employee Payscale, benefits, and compensation;
- 11. Discuss and consider action regarding purchase of a new Tender;
- 12. Discuss and consider action regarding FY 2025-2026 Budget;
- 13. Discuss and consider action regarding contract negotiations between ESD #4 and Martinez Architects for Architectural/Engineering Services for Fire Station 42;
- 14. Discuss and consider action regarding Carroll Czichos' retirement and Christopher Robbins assuming the Fire Chief position;
