Hays County Emergency Services District #4 will hold a Regular Meeting on **Tuesday, April 29, 2025, at 5:00pm,** at 111 Green Acres Drive in Wimberley, Texas for the following purposes:

- 1. Call meeting to order and verify quorum;
- 2. Public Comment: In accordance with the Texas Attorney General's opinion, any public comment that is made regarding an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes regarding items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 3. Approval of minutes from the regular meeting held on March 25, 2025;
- 4. Receive monthly Treasurer's Summary Report and consider approving payment of bills, issuance of checks, and monthly financial reports prepared by the District's bookkeeper;
- 5. Receive Quarterly Investment Report from District Investment Officer and consider approval;
- 6. Receive monthly report from Assistant Chief Robbins regarding emergency operations, personnel and management activities, training, and community outreach;
- 7. Receive monthly report from Chief Czichos regarding stations, apparatus, and equipment;
- 8. Discuss and consider action on monthly report from District's Attorney regarding pending litigation matters, contract issues, tax and budgeting issues, and legislative efforts;
- 9. Discuss and consider action regarding Independent Auditor's Report and Financial Statements for the year ended September 30, 2024;
- 10. Discuss and consider selling Copystar printer/scanner, model CS 356ci, approving the Resolution Authorizing Sale of Surplus Property, and authorizing the Board President to Execute the Resolution; take any related action;
- 11. Discuss and consider authorizing Assistant Chief Robbins to purchase a training door and additional sets of bunker gear; take any related action;

- 12. Discuss and consider action regarding contract negotiations between ESD #4 and Martinez Architecture for Architectural/Engineering Services for Fire Station 42;
- 13. Discuss and consider action regarding Hays County Mutual Aid Agreement and Auto Aid Agreement;
- 14. Discuss and consider action regarding FY 2025-2026 Budget;
- 15. Discuss date, time, location, and agenda items for the next meeting;
- 16. Adjourn.
