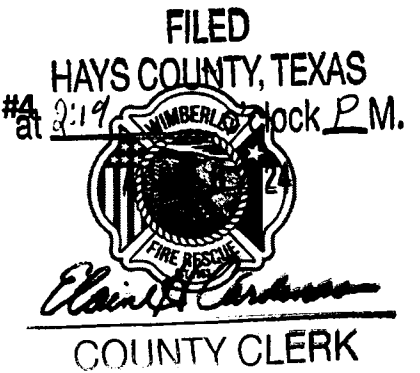

AUGUST 20, 2024



Hays County Emergency Services District #4 will hold a Public Hearing and Regular Meeting on **Tuesday, August 20, 2024, at 4:30pm**, at 111 Green Acres Drive in Wimberley, Texas for the following purposes:

1. Call meeting to order and verify quorum;
2. Public Comment: In accordance with the Texas Attorney General's opinion, any public comment that is made regarding an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes regarding items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

3. Consider taking action regarding budget for fiscal year October 1, 2024 to September 30, 2025;
4. Conduct a public hearing on the proposal to increase property taxes;
5. Take a record vote on the District's 2024 tax rate, adopt an Order Levying Taxes, authorize filing the Order with the County Tax Assessor/Collector; and
6. Acknowledge and approve posting of statement regarding adopted tax rate to home page of District website;
7. Approval of minutes from the regular meeting held on July 30, 2024;
8. Receive monthly report from the Treasurer and consider:
 - a) Approval of payment of monthly invoices including payroll; and
 - b) Approval of monthly financial reports prepared by bookkeeper;
9. Receive monthly report from Assistant Chief Robbins regarding emergency operations, personnel and management activities, training, and community outreach;
10. Receive monthly report from Chief Czichos regarding stations, apparatus, and equipment;

11. Discuss and consider action on monthly report from District's Attorney regarding pending litigation matters, contract issues, tax and budgeting issues, and legislative efforts;
12. Discuss and consider Chief Czichos' plan of succession;
13. Discuss time, place, date, and agenda items for next meeting;
14. Adjourn.
