- 8. Discuss and consider authorizing payment not to exceed \$8,100 for registration of 5 commissioners and 2 staff to attend the 2026 SAFE-D Conference, January 29–31, 2026, and hotel accommodations at Hilton Palacio del Rio, January 28–31, 2026;
- 9. Discuss and consider action regarding First Due Records Management System;
- 10. Discuss date, time, location, and agenda items for the next meeting;
