### HAYS COUNTY ESD #4 BOARD OF COMMISSIONERS AUGUST 19, 2025 MEETING MINUTES

- Mr. Joeseph Malone made the following motion: "I move that the property tax rate be increased by the adoption of a tax rate of 8.6960 cents per \$100 valuation, which is effectively a 31.36 percent increase in the tax rate." Mr. Grafia seconded.
- Mr. Pendleton voted FOR, Mr. Brown voted FOR, Mr. Malone voted FOR, Mr. Grafia voted FOR, and Mr. Transeau was ABSENT. Motion passed (4-0).
- Mr. Malone also moved to adopt an Order Levying Taxes and authorize filing the Order with the County Tax Assessor/Collector and was seconded by Mr. Grafia.
- Motion passed (4-0).

## 6. Acknowledge and approve posting of statement regarding adopted tax rate to home page of District website:

- A motion to acknowledge and approve posting of statement regarding adopted tax rate to the home page of the District's website was made by Mr. Malone and seconded by Mr. Grafia.
- Motion passed (4-0).

- Mr. Pendleton asked for corrections. Hearing none, the minutes were approved by unanimous consent.
