Hays County Emergency Services District #4 will hold a regular meeting on **Tuesday**, **July 30**, **2024**, **at 4:30pm**, at 111 Green Acres Drive in Wimberley, Texas for the following purposes:

- 1. Call meeting to order and verify quorum;
- 2. Public Comment: In accordance with the Texas Attorney General's opinion, any public comment that is made regarding an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes regarding items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 3. Approval of minutes from the regular meeting held on June 25, 2024;
- 4. Receive monthly report from the Treasurer and consider:
  - a) Approval of payment of monthly invoices including payroll; and
  - b) Approval of monthly financial reports prepared by bookkeeper;
- 5. Receive monthly report from Assistant Chief Robbins regarding emergency operations, response times, call volume, training, personnel, management activities, and community outreach;
- 6. Receive monthly report from Chief Czichos regarding stations, apparatus, and equipment;
- 7. Discuss and consider action on monthly report from District's Attorney regarding pending litigation matters, contract issues, tax and budgeting issues, and legislative efforts;
- 8. Discuss and consider taking action regarding 2024-2025 budget;
- 9. Discuss and consider taking action regarding 2024 tax rate, including:
  - a) Establishing proposed tax rate;
  - b) Taking record vote and scheduling public hearing;
  - c) Authorizing expense and publication of "Notice of Public Hearing on tax Increase" in the Newspaper; and
  - d) Acknowledging and approving posting of "Notice About 2024 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website.

- 10. Discuss and consider approval of the revised Public Information Act Policy and authorize the Board President to Execute the Resolution; take any related action;
- 11. Discuss time, place, date, and agenda items for next meeting;
- 12. Adjourn.
