- 5. Discuss and consider action regarding 2025 tax rate;
 - a) Establishing a proposed tax rate;

 - c) Authorizing expense and publication of "Notice of Public Hearing on Tax Increase" in the Newspaper; and
 - d) Acknowledging and approving posting of "Notice about 2025 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website;
- 6. Discuss date, time, location, and agenda items for the next meeting;
- 7. Adjourn.
