Hays County Emergency Services District #4 will hold a Special Meeting on **Tuesday, August 5, 2025, at 5:30pm**, at 111 Green Acres Drive in Wimberley, Texas for the following purposes:

1. Call meeting to order and verify quorum;
2. Public Comment: In accordance with the Texas Attorney General's opinion, any public comment that is made regarding an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes regarding items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

3. Discuss and consider action regarding Texas Legislature Special Session;
4. Discuss and consider action regarding purchase of radios and radio equipment;
5. Discuss and consider action regarding 2025 tax rate;
 - a) Establishing a proposed tax rate;
 - b) Taking a record vote and scheduling public hearing;
 - c) Authorizing expense and publication of "Notice of Public Hearing on Tax Increase" in the Newspaper; and
 - d) Acknowledging and approving posting of "Notice about 2025 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website;
6. Discuss date, time, location, and agenda items for the next meeting;
7. Adjourn.
